I.

The name of this corporation is Two Meter Area Spectrum Management Association of Southern California.

II.

This corporation is a nonprofit mutual benefit corporation organized under the Nonprofit Mutual Benefit Corporation Law. The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under such law.

III.

The specific purpose of this corporation is to further the development and administration of a Band Plan for the efficient and equitable use of the Two Meter Amateur Radio Band in the region generally referred to as Southern California, consistent with the needs of the Amateur Radio Community and the Rules and Regulations of the Federal Communications Commission.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
